SUPERVISOR, JOHN HERREMANS, CALLED THE MEETING TO ORDER AT 7:00 P.M. THE PLEDGE OF ALLEGIANCE WAS RECITED. ROLL CALL TAKEN – ALL BOARD MEMBERS PRESENT. ASSESSOR, DAN KIRWIN, WAS ABSENT. GUESTS WERE LORI GREEN, ALLEN BLOHM, PHIL CARTER, STACY LARSEN, MARIA TRIVISONNO & MORGAN KRUPPE. MOTION WAS MADE BY PURDY AND SUPPORTED BY E. KRUPPE TO ACCEPT THE MAY MINUTES. CARRIED. THE TREASURER'S REPORT FOR JUNE WAS GIVEN.
