FEBRUARY 9, 2015

SUPERVISOR, JOHN HERREMANS, CALLED THE MEETING TO ORDER AT 7:00 P.M. THE PLEDGE OF ALLEGIANCE WAS RECITED. ROLL CALL TAKEN – ALL BOARD MEMBERS PRESENT. ASSESSOR, DAN KIRWIN, WAS ABSENT. GUESTS WERE STEVE GATES, LUKE & DUKE KRUPPE. MOTION WAS MADE BY PURDY AND SUPPORTED BY E. KRUPPE TO ACCEPT THE JANUARY MINUTES. CARRIED. THE TREASURER'S REPORT FOR FEBRUARY WAS GIVEN. THE CLERK AND TREASURER DID NOT BALANCE. THE DISCREPANCY WAS KNOWN AND THE CLERK WILL MAKE THE PROPER ADJUSTMENT TO BALANCE.

OLD BUSINESS: AFTER SHORT DISCUSSION, MOTION WAS MADE BY D. KRUPPE AND SUPPORTED BY PURDY TO APPROVE THE PROPOSED 2015-1016 FIRE DEPARTMENT BUDGET. CARRIED.

THE MARCH BOARD OF REVIEW DATES WILL BE MONDAY, MARCH 9TH FROM 9:00 A.M. TO 12:00 P.M. AND 1:00 P.M. TO 4:00 P.M. AND WEDNESDAY, MARCH 11TH FROM 2:00 P.M. TO 5:00 P.M. AND 6:00 P.M. TO 9:00 P.M.. THE ORGANIZATIONAL MEETING WILL BE TUESDAY, MARCH 3RD AT 6:00 P.M. THE ASSESSOR WILL BE AT THE TOWN HALL ON SATURDAY, FEBRUARY 21ST FROM 10:00 A.M. TO 1:00 P.M. TO ANSWER ANY RESIDENTS QUESTIONS REGARDING TAXES.

THE CLERK ANNOUNCED ALL THE ENTITIES WHO WERE BILLED FOR THE NOVEMBER ELECTION HAD NOW REIMBURSED THE TOWNSHIP.

NEW BUSINESS: THE CLERK PRESENTED THE BOARD A PROPOSAL FOR THE TOWNSHIP TO PARTICIPATE IN THE ANNUAL HOUSEHOLD HAZARDOUS WASTE PROGRAM. THE BOARD DECIDED NOT TO PARTICIPATE IN 2015.

THE PRELIMINARY BUDGET PROPOSALS FOR 2015-2016 FOR THE TOWNSHIP AND FIRE DEPARTMENT WERE PRESENTED BY THE CLERK TO THE BOARD. THE BOARD DECIDED TO KEEP ALL SALARIES FOR 2015-2016 AT THE CURRENT LEVEL.

THE SUPERVISOR RECEIVED A ROAD WORK REQUEST FROM THE ROAD COMMISSION AS TO WHAT ROAD WORK THE TOWNSHIP WOULD LIKE TO DO IN 2015. BECAUSE THE TOWNSHIP HAS NO ROAD MILLAGE AND CANNOT AFFORD TO DO ANY ROAD WORK, IT WAS DECIDED THE SUPERVISOR SHOULD RETURN THE FORM TO THE ROAD COMMISSION STATING NO WORK TO BE DONE.

THE BUDGET HEARING AND ORGANIZATIONAL MEETING HAVE BEEN SCHEDULED FOR MARCH 9TH AT 6:45 PM PRIOR TO THE REGULAR MARCH MEETING. THE CLERK WILL SEE THAT THE BUDGET HEARING IS ADVERTISED. THE CLERK STATED THE TOWNSHIP IS DUE FOR AN AUDIT THIS YEAR.
